The Share Ohio initiative was launched near the end of FY 2014 to help neighboring communities share resources. ShareOhio.gov is designed to make it easier for local governments to share capital equipment, like bulldozers and front loaders, to save tax dollars and get the most efficient use of existing assets.

At no cost to local governments, ShareOhio.gov allows entities to enter heavy equipment into a database for the purpose of loaning to and borrowing from other nearby communities. Users have the ability to track inventory within each department and facilitate internal sharing of equipment as well. To help management make better inventory decisions, ShareOhio.gov also includes a feature that measures utilization rates for each piece of equipment and provides a variety of reports to help monitor usage.

The Agreement as proposed fulfills the written consent requirement of **Ohio Rev. Code Section 9.482** authorizing intergovernmental shared services. Benefits of signing the Agreement include:

Formal Agreement: With the mutual consent provided therein, the Agreement authorizes political subdivisions to exercise any power, function, or service for one another. It applies to both non-emergency and emergency situations.

Tort Immunity: Political subdivision tort liability law applies to parties to the Agreement and to their employees when they are rendering a service outside the boundaries of their employing political subdivisions under the Agreement.

Workers Compensation: Borrowing employers will now enjoy workers compensation protection, otherwise only available to lending parties. Employees are also entitled to all rights and benefits of workers' compensation law through their employer subdivision, paid by the borrower for the purposes of the shared service.



Voluntary Nature: Providing aid and assistance is optional. The needs of your community always come first. Lender may deny resources, direct its personnel to provide assistance, and recall resources at any time.

Flexible Reimbursement: Measure of reimbursement for use of equipment, materials, and supplies shall be as deemed appropriate by the parties.

Repairing Equipment: Borrower is not required to reimburse for costs of normal wear and tear; Borrower shall use reasonable care at all times.


FEMA Reimbursement: In case of a federally declared emergency, the agreement aids participating parties in obtaining FEMA reimbursement (FEMA reimbursement is contingent upon a pre-event, signed agreement).

Full Emergency Expenses: Agreement allows for FEMA reimbursement beginning immediately. While the Ohio Rev. Code only provides for reimbursement after the first eight hours of a declared emergency, this Agreement permits parties to seek reimbursement for the whole time.

Termination Clause: Parties are free to exit the Agreement at their will. The Agreement contains a 30-day notice termination clause.







Jurisdictional Boundaries


