



NACE LEGISLATIVE PRIORITIES

Streamlining Funding Safety

FAST ACT

- Fixing America's Surface Transportation Act
- Signed into Law December 4, 2015
- 5 Year, \$305 B

FUNDING

- Modest Increases in Funding
- Potentially more funding for locals
- Increases sub-allocation to locals
- Maintains off-system bridge set aside
- More transparency on where funds are spent.

STREAMLINING

The FAST Act:

Adds New Flexibilities Section 4(f) exemption for some bridges Authorizes taking of nesting swallows in at-risk bridges Refines Existing Provisions Narrows concurrence requirement for PEL Pilot for substitution of State law for NEPA

STREAMLINING

- Adds to Procedural Requirements
 - Requires a schedule, a checklist, and response to project initiation
 - Adds some new specific time frames for notices and reviews
- Builds on Existing Activities Requires permitting dashboard (but covers all EISs & EAs)

DOT to maximize use of authority to delegate project oversight to States on both a project and programmatic basis

PREVIOUS STREAMLINING ADVANCES (MAP-21)

- Declares it is in the national interest to expedite delivery of surface transportation projects by substantially reducing the average length of the environmental review process.
- Advances the use of best practices to accelerate project delivery, reduce costs across all modes, and expedite the deployment of technology and innovation.
 - Engage interested parties and stakeholders.
 - Establish a clearinghouse for new innovative approaches and best practices.
 - Disseminate information on innovative approaches and best practices.
 - Provide technical assistance to public transportation stakeholders.

PREVIOUS STREAMLINING ADVANCES (MAP-21)

Categorical Exclusions:

- New CE: Projects to repair roads damaged in declared emergency (Sec. 1315)
- New CE: Projects within existing operational right-of-way (Sec. 1316)
- New CE: Projects receiving limited Federal assistance (Sec. 1317) <\$5M
- Redesignation of some (d) list CEs to (c) list (Sec. 1318(c))
 - Modernization of a highway (771.117(d)(1))
 - Highway safety or traffic operations improvements (771.117(d)(2))
 - Bridge rehabilitation, reconstruction, or replacement projects (771.117(d)(3))

LEAP PROGRAM

Local Empowerment for Accelerating Projects

- "The American Public Works Association (APWA), National Association of County Engineers (NACE), and other local entities have advocated for improvements to the Federal-aid Highway Program delivery to LPAs."
- Experimental Program giving federal aid directly to locals



Funding – Good

- FY16 \$2.45 billion
- FY17 \$2.51 billion
- FY18 \$2.56 billion
- FY19 \$2.6 billion
- FY20 \$2.66 billion

Bad

- Doesn't fix HRRR
- Limits Use of HSIP Funds
- Gives States way out for collecting Unpaved Road data which prevents using HSIP on those roads
